No fee and funds upto VIIIth Class for both boys and girls. No tuition fee from girl students (Model & Non-Model). 2.

SC/ST boys are also exempted from Puttion Fee.

Funds will be charged half from SC/ST students both boys and girls

Smart sections students will be charged Rs.150/ per month in addition to the normal fees and funds.

No tuition fee will be charged from all boys students belonging to Muslims/Christians/OBC, handicapped, Freedom Fighters Ex-serviceman, Widows, divorces having family income below the limit of 1.5. laes per year.

Boys students of all rural schools will also be exempted from half tuition fee if they provide a proof of residence and of income limit below Rs.1.5 lacs oer annum.

These rates of Fee/Funds shall be valid for minimum three years.
